Sub : Tamil Nadu State Co-operative Societies Election Commission – Conducting of Election to Co-operative Societies coming under Phase-I- Reviewing the position of No Nomination societies – Instruction – Issued.

The State Election Officers are aware that with the completion of election to Co-operative societies coming under Phase-I in four stages, the commission has communicated the Election Programme for societies coming under Phase-II and the election process has since commenced in respect of these societies. Out of 22.212 Co-operative Societies coming under Phase-I, elections were held 20601 societies and in respect of 1611 societies elections could not be held since No Nominations have been received from these societies. A list showing the State Election Officer wise details regarding elections held and not held due to No Nomination is enclosed. The State Election Officers are requested to confirm the figures at once.

2) The Commission has understood, that eventhough in most cases where there are No Nominations, they may be due to the dormant status of the societies, there are also some other Potential societies where the Non-receipt of Nominations may be due to various other factors that prevailed at that time and the commission wants the State Election Officers to review the position thoroughly and send a list of societies for which another opportunity may be given to elect their representatives democratically. The State Election Officers are also requested to send list of societies where there is no possibility to conduct the elections even now and pursue necessary statutory action in respect of these societies as per the provisions contained in the TNCS Act 1983 and TNCS Rules 1988 to liquidate and to cancel the Registration of such societies as per necessity so that the need for conducting election to such Co-operative societies does not arise again.

3) The State Election Officers are requested to give top most priority to this item of work and ensure sending their report in this regard before 25.05.2013 without fail.
