The State Election Officers are aware that elections in respect of Co-operative Societies coming under Phases I, to III were already over and the elected Board of Management have also assumed office in respect of societies where elections were already over. The Tamil Nadu State Co-operative Societies Election Commission has also announced programme for conduct of elections in societies coming under Phase-IV which is expected to be over by the end of August'2013. After that the Tamil Nadu State Co-operative Societies Election Commission will announce the election programme for a lone society under Phase-V i.e., Tamil Nadu Co-operative union and with that the main election process 2013 will reach completion stage.

2) In this connection the State Election Officers and District Election observers are informed that the election related events under five Phases of elections to Co-operative Societies have to be documented in the form of an Administrative Report and presented to the Government. In order to make the report more vivid and lively, the Tamil Nadu Co-operative Societies Election Commission likes to add more photographs to the report and the State Election Officers and Election observers are requested send photographs featuring election related events such as.

1) Publication of Voters list 2) Filing of Nomination 3) Casting of votes in the election  
4) Counting of polled votes 5) Declaration of result 6) Assumption of Charge etc.

3) The Photographs should be in multi colour. The caption for the photograph should be neatly typed on a paper and pasted on the backside of each photograph. A part from the above referred events. Photographs featuring election classes conducted training programmes conducted, or the review meetings conducted by the Commissioner and Secretary of the commission during their visit to the Districts should also be sent to the commission. The Photographs covering the elections already concluded and also the proposed elections in the remaining two phases shall also be covered and the concerned photographs sent to the commission.

4) The Commission shall prepare the report based on the materials and statistics available with it. Apart from this, if the State Elections Officers and observers send reports covering Special events covering the elections, that shall also be included in the report. Hence the State Election Officers and observers are requested to send report about interesting events, their personal experiences, challenges faced and situations tackled hitherto unpublished information regarding elections etc., The photographs and reports in respect of the three phases of elections already over shall be sent in a name cover addressed to the Secretary of the commission before 31.7.2013. The Photographs covering events in respect of the remaining two phases shall be sent as when such events are over. The State Election Officers and observers are requested to treat this as specially urgent.
