***Communication of Election Programme under sub-rule (5) of
Rule 52 of the Tamil Nadu Co-operative Societies Rules 1988.***

The Tamil Nadu State Co-operative Societies Election Commission, constituted under sec. 33-A of the Tamil Nadu Co-operative Societies Act, 1983, hereby communicates the Election Programme, as drawn by the Election Commission under sub-rule(5) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 for the conduct of the elections to fill up the Casual Vacancies of Board of Directors and Office Bearers in the Apex Cooperative Societies under the administrative control of the Registrar of Cooperative Societies/State Election Officer as reported in his letter PDL.No.59/2014 CE.1, Dated.20.05.2014.

2) The number of Apex Cooperative Societies in which Casual Vacancies of Board of Directors and Office Bearers exists and the Category wise Casual Vacancies as reported by the Registrar of Cooperative Societies/ State Election Officer is annexed herewith (Annexure – I)

3) The Election Programme for conduct of Elections to fill up the Casual Vacancies of Board Directors and Office Bearers in Apex Cooperative Societies under the control of the Registrar of Cooperative Societies/ State Election Officer is also enclosed herewith (Annexure –II).

4) The Registrar of Cooperative Societies/State Election Officer is directed,

- 1) To inform the Apex Co-operative Societies concerned about the elections to fill up the Casual Vacancies.
- 2) To communicate the Election Programme to the District Election Officers and to the concerned Apex Co-operative Societies for which the Elections are to be held.

5) The District Election Officers are directed to fix the places for filing of Nomination, conducting of poll, and counting of votes as required under columns in the Election Programme.

6) The District Election Officers are also directed to issue Election Notice as required under sub-rule 6(a) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 to the members who on the date thirty days prior to the date of poll were members of the society and conduct the Election in accordance with the provisions contained in Tamil Nadu Cooperative Societies Act, 1983 and the Tamil Nadu Co-operative Societies Rules 1988, and also as per the directions, instructions and guidelines issued by this Commission from time to time.
