The District Election Officer is directed to fix the place for filing of Nomination, conducting of poll, and counting of votes as required under columns in the Election Programme.

The District Election Officer is also directed to issue Election Notice as required under sub-rule 6(a) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 to the members who on the date thirty days prior to the date of poll were members of the society and conduct the Election in accordance with the provisions contained in Tamil Nadu Cooperative Societies Act, 1983 and the Tamil Nadu Co-operative Societies Rules 1988, and also as per the directions, instructions and guidelines issued by this Commission from time to time. The District Election Officer is also directed to appoint Electoral officer under Rule 52(1) (c) and Election officer under Rule 52(3)(a) and for the conduct of office bearer election appoint Election officer Under Rule 53(1)(a).
