The District Election Officers are directed:

1) To fix the place for filing of nomination, conducting of poll and counting of votes as required and mention the same under the respective columns in the Election Notice.

2) To issue Election Notice as required under sub-rule 6(a) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988, to appoint Electoral Officers under Rule 52(1) (c), Election Officers under Rule 52(3) (a) for the Conduct of Election of Members of the Board as per Rule 52, to appoint Election Officers under Rule 53(1) (a) for the conduct of Election of Office Bearers of the Boards of the Co-operative Societies as per Rule 53 of the Tamil Nadu Co-operative Societies rules,1988, and as per the directions, instructions and guidelines issued by the Commission from time to time, and

3) To direct the Election Officers to send the reports required statutorily to the Election Commission immediately on the completion of each process of Election.
