The Tamil Nadu State Co-operative Societies Election Commission, constituted under sec. 33-A of the Tamil Nadu Co-operative Societies Act, 1983, hereby communicates the Election Programme, as drawn by the Election Commission under sub-rule(5) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 for the conduct of the elections to Nine Cooperative Societies Communicated in letter R.C. The Election programme for Conduct of Election to the above referred Nine Cooperative Societies is enclosed herewith (Annexure-II).

The Concerned State Election Officers are directed,

- 1) To inform the concerned Cooperative Societies about the Elections.
- 2) To communicate the Election Programme to the concerned District Election Officers and to the concerned Cooperative Societies .

The District Election Officers concerned are directed to fix the place for filing of Nomination, conducting of poll, and counting of votes as required under columns in the Election Programme.

The District Election Officers are also directed to issue Election Notice as required under sub-rule 6(a) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 and conduct the Election in accordance with the provisions contained in Tamil Nadu Cooperative Societies Act, 1983 and the Tamil Nadu Cooperative Societies Rules 1988, and also as per the directions, instructions and guidelines issued by this Commission from time to time. They are also directed to appoint Electoral Officers under Rule 52 (1) (c) and Election Officers under Rule 52 (3) (a) and for the conduct of office bearer election appoint Election Officers under Rule 53 (1) (a).

The District Election Officers should direct the election officers to send the following reports directly to the Election Commission on that day itself.

- a) Nominations filed (Rule 52(8) a to c),
- b) Publication of final list of valid Nomination (Rule 52 (8) (i) and Rule 52 (9),
- c) Election Results Published (Rule 52(16)).
