Communication of Election Programme under sub-rule
(5) of rule 52 of the

Tamil Nadu Co-operative Societies Rules 1988.

The Tamil Nadu State Co-operative Societies Election Commission, constituted under sec. 33-A of the Tamil Nadu Co-operative Societies Act, 1983, hereby communicates the Election Programme, as drawn by the Election Commission under sub-rule(5) of rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 for the conduct of the elections to the co-operative societies in the State.

The conduct of Election to the Co-operative Societies in the State will be held in five phases (Annexure -I and I(a))

The Election to the Co-operative Societies in phase-I will be held in 4 stages. (Annexure II) The Election Programme drawn up for Phase-I is annexed herein. (Annexure- II (a))

The State Election Officers are directed,

- 1) To inform all the societies about the elections under five phases and;
- 2) To communicate the Election Programme (Annexure- II and II (a)) to the District Election Officers and to the concerned Co-operative Societies under phase- I.

The District Election Officers are directed to fix the places for filing of Nomination, conducting of poll, and counting of votes as required under columns in the Election Programme.

The District Election Officers are also directed to issue Election Notice as required under sub rule 6(a) of rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 and conduct the Election in accordance with the provisions contained in Tamil Nadu Cooperative Societies Act, 1983 and the Tamil Nadu Cooperative Societies Rules 1988, and also as per the directions, instructions and guidelines issued by this Commission from time to time.
