ORDER:

In the Proceedings cited under sub-rule 6(a) of Rule 52-A of TNCS Rules 1988 orders were issued appointing the Additional Registrar of Co-operative Societies. Chennal Region and the Joint Registrars as Electoral Roll Observers for conducting of elections to all the Co-operative Societies including the Co-operative Societies coming under the control of Functional Registrars in Tamil Nadu. In the same Proceedings Orders were also issued fixing the duties and responsibilities of Electoral Roll observers which is mainly confined to monitoring of preparation and publication of voters list including taking decision on the claims made or objections raised on the voters list published by the Electoral Officer within the time limit specified. Now that the process of preparation and publication of voters list is on, the process of election moves on to its next stages such as filing of Nomination, conducting of poll if necessary, counting and declaration of election results, conduct of election to the post of President / Vice-President etc. It is therefore hereby ordered that all the Electoral Roll Observers so far appointed are hereby designated as observers and they shall monitor all the process of election to Co-operative societies and including the societies coming under the control of functional Registrars. The observers shall exercise the powers vested with them under sub-rule 6 (b) & 6(c) of Rule 52-A of TNCS Rules 1988. They shall also perform such duties and responsibilities as may be entrusted to them by the commission from time to time. The observers shall also perform the duties and responsibilities of the Electoral Roll Observers till that duty is over and shall automatically move on to perform the duties and responsibilities of Observer. In short the overall monitoring of the conduct of election to the Co-operative societies including the Co-operative societies coming under the control of functional Registrars as per TNCS act 1983 and TNCS Rules 1988 shall vest with the Observers and as an officer on deputation to the Tamil Nadu State Co-operative Election Commission, the Observers are directed to act as eyes and ears of Election Commission in respect of their District concerned perform their duties and with due diliaence utmost care.
