Appointment of Electoral Roll Observers - Orders - Issued.

#### ORDER:

The Tamil Nadu State Co-operative Societies Election Commission has been constituted under Section 33-A of Tamil Nadu Cooperative Societies Act 1983. Under the Powers vested with the Tamil Nadu State Co-operative Societies Election Commission under Sub-rule 6(a), of Rule 52-A of Tamil Nadu Co-operative Societies Rules 1988, the Commission hereby appoints the Additional Registrar/Joint Registrar of Co-operative Societies noted in the Annexure to this Proceedings as Electoral Roll observers for conducting of Elections to all the Co-operative Societies including the Co-operative Societies coming under the control of functional Registrars in Tamil Nadu. The observers appointed shall constantly monitor and ensure that the time limit specified in Tamil Nadu Cooperative Societies Rules 1988 and in the election schedule are followed strictly in the following functions.

- (i) that the Society prepares and furnishes members list to the Electoral Officer appointed by the District Election Officer and publishes the members list in the notice board at the office of the Society within the time limit.
- (ii) that the Electoral Officer Prepares and publishes the Voters list in the notice board at the office of the Society within the time limit.
- (iii) that the members make their claims or raise objections to the voters list within the time limit.
- (iv) that the Electoral Officers take decision on the claims made or objections raised on the Voters list within the time limit specified and publishes the voters list within the time limit specified.
- (v) that in the event of the Society failing to prepare and furnish the members list within the time limit specified, whether the Electoral Officer himself prepares and publishes the voters list in the notice board at the office of the Society within the time limit specified.
- (vi) that the members make claims or raise objections to the above voters list published by the Electoral Officer within the time limit specified.

- (vii) that the Electoral Officer takes decision on the claims made or objections raised to the voters list within the time limit specified and publishes the voters list within the time limit specified.
- (viii) that the provisions of Sub-rule 6(a), (b), (c), (d) and Sub-rule (7) of Rule 52 of Tamil Nadu Cooperative Societies Rules 1988 are strictly adhered to by the Societies and Electoral Officers.
- (ix) other tasks that may be entrusted from time to time.
- (2) The observers are requested to bring to the notice of the concerned State Election Officers and to this commission regarding violation of Rules if any in the preparation and publication of Electoral Rolls immediately over Fax / E-Mail followed by post copy in confirmation.
