**Communication of Election Programme under sub-rule (5) of  
Rule 52 of the Tamil Nadu Co-operative Societies Rules 1988.**

The Tamil Nadu State Co-operative Societies Election Commission, constituted under sec. 33-A of the Tamil Nadu Co-operative Societies Act, 1983, hereby communicates the Election Programme, as drawn by the Election Commission under sub-rule(5) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 for conduct of the elections to fill up the Casual Vacancies of Board of Directors and Office Bearers in Cooperative Societies in the State as reported by the State Election Officers.

2) The State Election Officerswise Number of Cooperative Societies in which Casual Vacancies of Board of Directors and Office Bearers exists and the Category wise Casual Vacancies as reported by the State Election Officers are annexed herewith (Annexure – I)

3) The Election Programme for conduct of Elections to fill up the Casual Vacancies of Board of Directors and Office Bearers in Cooperative Societies is also enclosed herewith (Annexure –II).

4) The State Election Officers are directed,

- 1) To inform the Co-operative Societies concerned about the elections to fill up the Casual Vacancies.
- 2) To communicate the Election Programme to the District Election Officers and to the concerned Co-operative Societies for which the Elections are to be held.

5) The District Election Officers are directed to fix the places for filing of Nomination, conducting of poll, and counting of votes as required under columns in the Election Programme.

6) The District Election Officers are also directed to issue Election Notice as required under sub-rule 6(a) of Rule 52 of the Tamil Nadu Co-operative Societies Rules, 1988 to the members who on the date thirty days prior to the date of poll were members of the society and conduct the Election in accordance with the provisions contained in Tamil Nadu Cooperative Societies Act, 1983 and the Tamil Nadu Co-operative Societies Rules 1988, and also as per the directions, instructions and guidelines issued by this Commission from time to time. They are also directed to appoint Electoral officers under Rule 52(1) (c) and Election officers under Rule 52(3)(a) and for the conduct of office bearer election appoint Election officer Under Rule 53(1)(a). The Directions issued by the Government under section 170 of Tamil Nadu Co-operative Societies Act, 1983 in G.O. MS.No.49 Co-operation Food and Consumer Protection Department Dated 4.4.2013 exempting all the primary Co-operative Societies from the provisions of the first proviso to clause (a) of sub-section (1) of Section 33 of the said ACT, if such society has no such member from the category of women or from the class of SC and ST's as the case may be, shall also be kept in mind.
